## 1. Welcome and introductions

---

Attendees were welcomed to the workshop and introductions were made around the room. The purpose of the day was to:

- Share the evidence of needs in South Kilburn
- Share current work that has been collated from the community mapping exercise and one to one conversations.
- Discuss and agree emerging themes and priorities for action for organisations to work together on, that have come from the conversations and evidence review
- Explore and clarify how organisations work together in taking these forward and delivering.

## 2. How we will work together today

- Potential of organisations working for the good of the area
- Community coming together
- Community and the people
- Network of organisations and how they work together
- Extraordinary wealth of organisations – rich and diverse
- Vibrant / fascinating place to work
- The love the community has for South Kilburn
- Amazing community of all ages who love the community

## 4. Scene setting

LBB provided an overview of the South Kilburn Regeneration Project

It was highlighted that;

- the work of Community Regen is a start, and lays the foundation for wider conversations that now need to be had in the community.
- There is a need to ensure an opportunities around social value are aligned to the emerging priorities.
- There is a need to consider how and who takes this work forward.

Below is a map demarcating the boundaries of South Kilburn.



## 5. Feedback on evidence of need and mapping data

---

The following feedback and questions were asked at the end of the presentation of the evidence of need and mapping data:

- Health - All the priorities impact health
- Gender and ethnicity – there is a gap in data that looks at the intersection of age, gender and ethnicity across., look at public health data
- It would be valuable to include a map that shows South Kilburn boundaries
- Hold conversations around South Kilburn in context of the larger area
- Was any research done on digital inclusion?

## 6. Discussion – Recommendations

---

Participants were divided into 6 groups. Each group were asked to discuss:

*(please see Appendix 3 for list of recommendations)*

### 1. Do you agree with the recommendations in the report?

#### **Group A**

- Yes, as a starting point but wordy – unpack and more focused – don't get lost this has been done before!
- Recommendation A and F interlinked i.e. information on current services and Governance.

#### **Group B**

- Yes but....., great starting point but lots of fine tuning

#### **Group C**

- Agree better information needed by residents – e.g. provision for young people
- Need to get residents voice
- Similar to most communities
- Is first stage

#### **Group D**

- Not entirely

### 2. Is there something you would like to change, add or amend at this stage?

#### **Group A**

- No mention on food insecurity
- Loss of local amenities and lack of culturally appropriate food access
- No access to food in school – NRTPF / only primary schools
- Nothing about gender

- More targeted – useful to have desegregated data.
- Community spaces – management coordinated (governance) to make accessible.
- Poverty reduction – role from central and local governments not all local lead
- Young people – all need increased training for all.
- The two schools merged – opportunity for more coordination of wrap around family services.
- How to access council funding and join up

### *Group B*

- Fine tuning
- Measuring impact – how?
- Co-production – residents voice
- Accountability – housing providers, developers, Council

### *Group C*

- Health and employment – cut across or under poverty reduction – more work to unpack some headings.
- SK residents need to know about local residents
- Include new JSC centre on Salisbury Road
- Structures for residents to engage in ongoing ways
- More about social value from developers – needs to be done well and through governance structures

### *Group D*

- Want the specifics of what constitutes SK to be clear in its own right
- Health needs to be addressed – many of the things highlighted in the themes have an overall impact of health. – Interweaved specific: COPD, long COVID, mental health (severe)
- Sports and educational facilities – are they being mapped? Need to be aware of this
- How to access CIC funding and join up so community can contribute



## 7. Feedback on the recommendations

---

Following feedback from the groups there was an open discussion on the recommendations, comments included the following;

- Themes need to be unpacked more
- Finetune the recommendations – how will impact be measured? What's the baseline?
- Social Value – more information from developers – respond to residents needs
- Better information and signposting for residents
- Be clear about what constitutes as South Kilburn
- Health needs missing from recommendations
- Some will be impacted a number of times by a number of themes
- We need engagement from health – Will the Medical Centre in South Kilburn be open?
- There will be a community newsletter created and distributed by the Council which will include information about facilities
- Recommendations need to be unpacked more
- Food insecurity and poverty would come under the poverty priority.
- There is a need for Education for all – not just young people
- Adequate for the time being
- Co-production – residents voices involved
- Legacy – what does it mean for the people and the area?



## 8. Creating an action plan

After discussing the recommendations, participants were split into groups, each group was asked to discuss the actions needed to deliver priorities for action.

The six priorities for action discussed:

1. Community assets – access / how can buildings be used better?
2. Young people – children and teenagers
3. Health and wellbeing particularly vulnerable residents
4. Employment / education and training / poverty
5. Community Voice
6. Governance – impact / legacy / how to set up something that will deliver

- A much bigger network of SK useful contacts
- New ideas and positivity

### **One thing I will do**

- Facilitate connections within the community
- More community spaces. Most in South Kilburn use faith halls, so we need more mutual spaces
- I will take the learnings from this workshop to help develop some ideas for how we can incorporate environmental projects into the work going on in South Kilburn, and see if it is viable to develop a Green neighbourhood in this area. I will set up 1:1 meetings with individuals met in this group to help better understand the community's needs and how the climate team at Brent might be able to support here.
- Work on GCK commitment to action plan
- Take up the opportunities to engage and contribute when I am able to add to the activity.
- Take forward the governance steps re working party.
- Help to facilitate communicating the next steps

## APPENDIX – 3

### Recommendations

- a) **Information on current services** – building on the mapping exercise, partner organisations should:
- i. Continue to develop a deeper understanding of what organisations are doing in South Kilburn, who they are working with, and how people can access their services.
  - ii. Clarify ways to update and disseminate the mapping information about services and activities in South Kilburn
- b) **Priorities for action** - *subject* to wider discussions and community engagement, partners agree the following shared priorities for action that builds on local strengths and existing work;
- i. Community assets and spaces – improve access and use of local community spaces.
  - ii. Young people – increase the quantity of youth activities available to young people in South Kilburn.
  - iii. Vulnerable residents – increase targeted and coordinated mental health support and -well-being initiatives and support.
  - iv. Poverty reduction – work together to further develop and support community-led approaches to tackling poverty.
  - v. Community voice – build and foster a resident community voice that is inclusive, informed and that fosters ongoing dialogue between residents and partners in South Kilburn
- c) **Partner organisations & the community** – partners should strengthen ways for local people to know about and access their services. This could include;
- I. Ensure all partners are aware of the range of local services and activities and commit to joint arrangements through a simple Partnership Agreement.
- d) **Partner organisations & organisational collaboration** – partner organisations should:
- i. Explore ways to share information where appropriate and respecting GDPR in providing holistic support to South Kilburn residents. through shared tracking of referrals and their outcomes.
  - ii. Develop a shared approach to outreach and engagement in the neighbourhood.
  - iii. Referrals & Signposting – explore ways to develop a shared way to refer residents to different partner organisations.
  - iv. Sharing Data & Outcomes – explore sharing data on resident needs (not compromising GDRP) to strengthen partner organisations evidence of local need to assist their funding applications.
- e) **Resourcing the delivery of the priorities for action**
- I. Ensure existing priorities of statutory partners are aligned to the emerging community priorities.
  - II. Ensure all social value KPIs going forward are aligned to community priorities for action.
- f) **Governance Arrangements** - partner organisations in South Kilburn to deepen and strengthen existing collaboration and decision making with a focus on an asset based approach. The collaboration should;
- i. Review and clarify the purpose of working together in South Kilburn i.e. governance structure. Membership and ensure accountable and transparent

- decision making and oversight of resources e.g. social value with clear mechanisms in place to manage conflicts of interest.
- ii. Discuss and agree how to underpin the partnership work with a resident community voice.
  - iii. Confirm what partners work together on and how.
  - iv. Explore developing joint bids and funding applications.
  - v. Clarify the resources partners can 'bring to the table'.
  - vi. Develop a new Terms of Reference and a Partnership Agreement to confirm the working arrangements between partners.
